Introducing the Certificate of Added Qualification (CAQ) Corner

On behalf of the Liver Transplantation CAQ Corner committee, we are pleased to announce that *Liver Transplantation* is relaunching the “CAQ Corner” to help our readers prepare for transplant hepatology certification and recertification.

Every month there will be one or two articles featured in the CAQ Corner. These concise CAQ Review Articles are clinically oriented and will cover the board topics as outlined in American Board of Internal Medicine (ABIM) Transplant Hepatology blueprint (<https://www.abim.org/Media/lo0jcigs/transplant-hepatology.pdf>). Each Review Article will be accompanied with five board type questions. In addition to providing useful board review, both Continuing Medical Education (CME) and Maintenance of Certification (MOC) Credit will be available for each article for up to one year after publication. After one year, the activities will expire, and credit will no longer be offered.

The American Association for the Study of Liver Diseases (AASLD) is partnering with its publisher Wiley to provide CME and MOC. Successful completion of these journal-based activities, which includes completion of the evaluation component, enables the participant to earn up to one Maintenance of Certification (MOC) point in the ABIM MOC program. Participants will earn MOC points equivalent to the amount of CME credits claimed for the activity. It is Wiley’s responsibility to submit participant completion information to ACCME for the purpose of granting ABIM MOC credit. To ensure processing of MOC credits, please ensure you have consented to data sharing with the ACCME/ABIM and have entered your diplomate information into your user profile on the learning portal.

Our first two papers in this section will cover the pediatric indications for liver transplantation and genetic liver diseases. These two topics combined cover 4%-8% of the board questions. These
