

#### From the Dean:

Following the BAM strike, two petitions from Business School students were addressed to the Dean. One expressed concern about the use of force and violence on campus and requested the School to do everything possible to preserve individual freedom and liberty. The other expressed concern about the plight of blacks in the nation and asked the School to make special efforts to increase black enrollment in the School.

The two petitions, though emphasizing different points, are not in conflict; actually they are complementary. As such, they will receive support.

The School has a long tradition in recognition of the merits of individual freedom and initiative. Continuing this tradition, the Business School Faculty adopted the following resolution by unanimous vote on May 1, 1970:

We affirm the right of every student to receive the full instruction to which he is entitled through his payment of tuition and fees. All members of the teaching faculty are expected to discharge fully their teaching and research responsibilities.

The Faculty also approved the unanimous action taken by the School's Executive Committee during the BAM strike:

The Executive Committee of the Graduate School of Business Administration reaffirms its deep concern over the continued disruption of the academic programs at The University of Michigan and urges that all necessary steps including police, or military protection if required, be taken to protect academic freedom, personal life and property, and to reestablish and maintain the normal operations of the University.

At the same time, the School's faculty and administration are deeply aware of pressing social problems and are anxious to contribute to their solution. For the past three years, significant efforts have been made to enroll more black students, obtain more fellowships for all of our students including blacks, introduce two special courses on black capitalism in the curriculum, and assist Tuskegee Institute to expand and improve instruction in business administration for its predominately black undergraduate student body. In the months ahead, the School will need all the help friends can give to increase the applications of qualified blacks and to provide corporate fellowships to enable them to attend.

The School is also calling upon its friends to help finance the construction of the Assembly Hall which will be the first unit in the advanced management complex. See page 4.

Alumni of the School will be especially pleased to learn of the favorable report of the Revisitation Committee of the American Association of Collegiate Schools of Business, the official accrediting agency for professional programs in

Business Administration. Excerpt from report:

"As a result of a careful analysis of the materials sent to us in advance, and as a result of detailed conferences with Dean Floyd Bond and key members of his administrative staff and faculty, we are of the opinion that the programs of the School of Business Administration and the Graduate School of Business Administration of the University of Michigan are thoroughly excellent and that they deserve their reputation for leadership among the nation's best degree programs."


#### To Our Alumni:

# Expanding the Resources for Management Education and Research

The University of Michigan's Graduate School of Business Administration is an established leader in its field. The School's physical plant works at peak load. Expansion is imperative.

The long-range plans which have been developed over the past five years provide for an advanced management complex as illustrated above. The present Business Administration building is shown in the left-hand corner of the picture. Haven Street has been closed, most of the houses on the adjoining block purchased and dismantled, and plans made for utilizing the full two-block area bounded by Monroe, South University, Hill, and Tappan for the present and future development of the Business School.

The parking structure, identified in the picture by the letter "P," will be ready for use at the beginning of the 1970 fall term.

The Assembly Hall, which will be the next unit to be constructed, will contain an auditorium, three case discussion rooms, quarters for the Executive-in-Residence, a lounge for use in conjunction with the auditorium, conference rooms, offices, and auxiliary services.

It was hoped the structure could be built for \$1 million, but it now appears it will cost between \$1.3 and \$1.5 million. The School is responsible for raising all of the funds for the structure. Half of the funds are already in hand, largely due to the generosity of friends of the School.

Site studies have been made, a building committee has been appointed, a "program statement" has been developed, architects have been hired, and a financial drive will begin soon.

The structure will serve both our degree programs and our executive development programs. We expect to make full use of the facility, both on a daily and year-around basis.
