On October 16, 2012, the ORCID initiative was officially launched and began to issue its unique identifiers.

In December of 2012, the UM Mlibrary signed a "Basic" member license agreement with ORCID.

The "Basic" membership allowed us to:

- create ORCID records for our faculty, librarians, and researchers,
- deposit to existing ORCID records, and
- employ various APIs (application program interfaces) along with the data that those APIs can access to perform tasks associated with an ORCID.

The consortial contract gives us "Premium" level membership allowing us, among other things, to:

- integrating ORCID iDs into multiple systems,
- use ORCID iDs in vendor-hosted systems and separate internal systems and,
- run analytics of the interactions between our systems and ORCID.

Click [this site](#) for instructions on how to integrate an ORCID with your **MCommunity**--a directory and identity management system for U-M-- with the new ID. The other option is to go to <https://orcid.org/signin> directly and either create a new ORCID username and password, or create a log in with your University of Michigan account. We recommend the second option, which links the University of Michigan account with the user's ORCID. To do so, click the Institutional Account tab and type in "University of Michigan" into the search box.

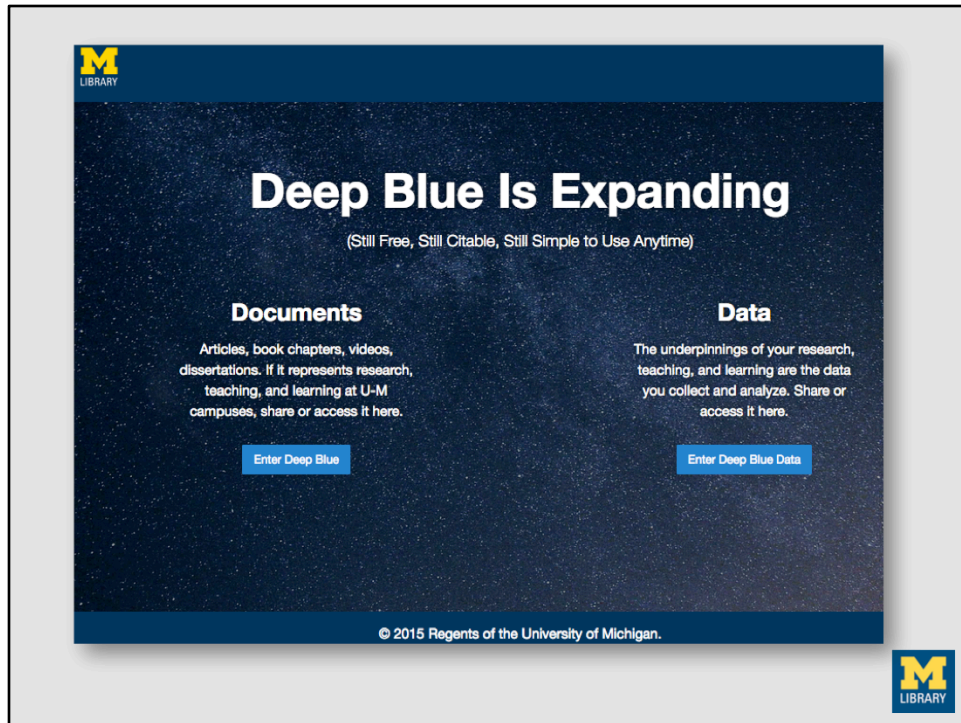

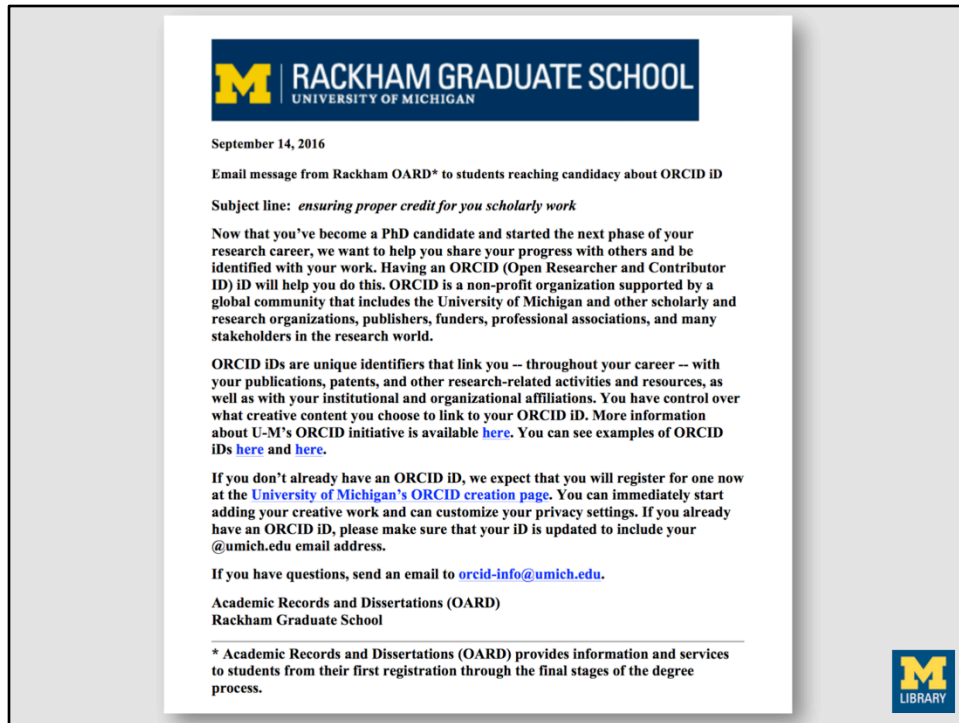

What is ORCID? And, how can it help you?

Authors, researchers and other scholars commonly find others sharing the same name. Winston Churchill, J. Janosky, and P. K. Mallick know named persons publishing in the same field as themselves. Publishers and funding agencies struggle with this ambiguity. Necessity is once again the mother of invention: an open, non-profit, international, community-driven effort has resulted in ORCID (Online Researcher and Contributor Identification), a registry of unique identifiers.

At its core, ORCID provides a unique number for any researcher, a number that can migrate with the researcher from one institution to another. Your name and the ID number become public. Optional, but useful, are the addition of employment history, research activities, grants, publications and other academic information. The owner of the ID can make any of these other categories private or public. Understandably, funding agencies and publishers are seizing the opportunity to reduce the confusion between authors and grant seekers.

The Mardigian Library will be working with the academic departments to offer faculty members the opportunity to be registered in ORCID. Faculty members can “opt-out” or can register themselves at <http://orcid.org>. For more information, go to <http://libguides.umd.umich.edu/orcid>. The Graduate Studies Office will do a final check for format and notify the student, graduate program director, and committee chair via university email account once approved. This final PDF digital copy will be the copy of record and will be submitted to [Deep Blue](#), a digital repository that is part of the University of Michigan Library, by the Graduate Studies Office after the degree has been conferred. Effective Winter 2016, Deep Blue requires an [ORCID number](#) in order to submit the dissertation.
