“Impact”

- Can be quantitative or qualitative
- All impact metrics are proxies for the concept we’re trying to measure
- We want to know something about the difference made by a particular research output

“Open”

- Discoverable on the open Web
- Available to read in full without a paywall
- Usually also available to download and share without cost to the reader

Open Access Citation Advantage

- Does it exist?
- Does it matter?
- Do we care?

Open Access Citation Advantage (OACA)

- A constant question since the early days of OA
 - The Budapest Initiative (2002) and the Berlin Declaration on OA (2003)
 - Research and debate on whether there is an OACA begins just a few years later (2006 or earlier) and continues to this day

Why are we so hung up on this question?

- We're forcing the justification/reason for OA to fit into existing norms of assessing research impact
- There can never be a “decisive” answer to this question, for all kinds of reasons
- It totally misses the point!!!!!! (most of the reasons we claim OA is a good thing will never be measured by citation counts!)

Can we please talk about something else?

- How findable and usable is your work?
- *Who* are the readers of your work?
- *Where* are the readers of your work?
- *How many* readers have found your work?
- *How soon* can people read your work?
- *Why* are people reading your work?
- *What difference* does it make?
- Etc.

What can we actually know, and how?

- *Who?:* Surveys? Tracking user data on the web? Capturing data from user log-ins?
- *Where?:* Web analytics; can only be done by the entity hosting the work,
- *How many? :* Download counts, fairly straightforward
- *How soon? :* Time to publication, embargoes, straightforward
- *Why? :* What difference does it make? Altmetrics, Policy, Citations, or.....we may never know!
- *Are we measuring the impact of the article, or the openness?*

**Problem: These things can
be hard, impossible, or
sometimes irresponsible to
measure**

What can we say with confidence ?
