Um, so, you know, we waited. It was important to me to wait until I was, no-, I was old-, but like a little bit older, um, than some people to have a child. Um, I had not like a super tumultuous childhood, but like, a little bit. And like my parents were divorced and it was just like, kind of, and they were like, had us kind of young and so I like, just always wanted like, not that. And so it was very important to, for me. Um, I've been with my now husband for like 17 years, but, um, we like waited a really long time, which is very important to me 'cause I wanted us to be like, settled, like have the whatever jobs we were gonna have, have a house we were gonna live in, like all of that stuff. So, um, that's just where I'm sort of coming from.

And, um, so we did that, you know, waited until, well, [laughter] until we had the jobs we're gonna have. Um, of course we were in the process of buying a house and then, and I was pregnant and, um, then the pandemic hit and everything got shut down and then we were like sort of panicking and, um, it was a very, the pregnancy was very like, I mean, I guess everybody's like, Covid pregnancies were sort of like weird in that sense. [S2 affirmative] Where it was like very isolated. Like, I had like, just told my coworkers in mid-February 2020 that I was pregnant, um, because I had gotten, like, I did like the, uh, I wanted to wait until I got like the prenatal, um, blood test, you know [S2 affirmative] and just like to find out everything was fine and whatever got like the, the gender and all that stuff.
