A highlight on the District 17 fall calendar is certain to be the October 17-23 Desert Empire Regional in Scottsdale, Arizona scheduled at a spectacular new site, the five-star

Talking Stick Resort/Casino. Because of tournament restrictions, Unit 354 has never been able to host this event in October, so leadership of the unit has been busy for months planning to make the week-long stay unforgettable for out-of-towners.

Phoenix is known for its friendly, laid back, Western-style hospitality so "Scottsdale in October," as the tournament is being branded should be a treat. The weather in the historic and renowned Scottsdale is ideal at that time of year with cool desert nights and sunny days, perfect for golfing, sight-seeing or sunbathing when not at the tables (bridge or casino).

The playing site is a 10-15 minute drive from Old Town Scottsdale, full of antiques and curio shops plus popular cafes and bars which mark the nightlife. Before or after the tournament visitors can take a two hour trip to Sedona, the home of extraordinary red rock formations often de-

scribed as a miniature Grand Canyon. Other sights to see include the beautiful and charming community of Carefree, with lovely mountain landscapes located north of Scottsdale.

Players can also take in the Phoenix Botanical Gardens and the Phoenix Zoo, as well as guided desert tours to see spectacular blooming flowers and wild animals in their natural habitat.

At Talking Stick there are 497 deluxe rooms with five restaurants which provide something for every taste - upscale dining spots, an international buffet, a seafood bar, lounges with entertainment, coffee shops, and food bars.

The tournament will have daily door prizes, including gift certificates for leading area restaurants. One of the most popular giveaways is the awarding of prizes for those who can guess the correct number of cards in a fish bowl. The "Guess the Cards" contest is held daily with prize winners posted.

ACBL Top 500 Clubs: Addendum

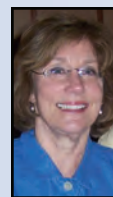

Last month's article in this publication spoke about the three bridge clubs in D17 honored to be in the ACBL's top 50. As we mentioned, the sole criterion by which the ACBL selects the top 50 clubs is table count. There are, however, many other worthy clubs and other criteria. One of our Phoenix readers wrote to tell us about his favorite club in the Phoenix area, Doty Bridge Club in Scottsdale, and we thought we'd share his opinion with you. For starters, he appreciates the fact that Doty has underground parking and great air conditioning. In a city where you can fry an egg on the sidewalk several months of the year, underground parking and great A.C. is a big deal, a very big deal. A cool car and cool ambiance help cool heads prevail around the table. He likes the light, airy atmosphere of Doty, with a main room that accommodates 25 tables with

enough space between each so that you can't hear the bidding, play, or bickering at neighboring tables, as well as another room just for novices. Doty has a very active novice program and twice a year offers six sessions of free lessons to introduce never-evers to the game; Doty has very reasonably priced intermediate lessons as well. Newcomers are encouraged to play, and a typical novice game has as many as 12-15 tables. Doty has a very well attended open game every day with as many as 25 tables. The caliber of the competition at the club is so keen that many of the area's finest players beat a path to Doty's door.

If you have a favorite club, we'd love to hear about it from you.

This month's change of pace column is about people - bridge people, past, present, and future. I will inform you about the Toronto NABC board meetings in a later column.

Past - Peter Pender

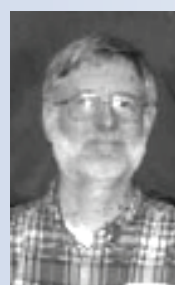


Although Peter Pender, San Francisco, was not a D17 player, he was a Western Conference member and dear friend of many of our D17 members. Peter was brought to my attention by Bobby Wolff and Judy Kay-Wolff. He was a multi-faceted, brilliant man who became Life Master #1795 at the age of 22. He won the 1966 McKenney trophy (now the Barry Crane Top 500) and tallied 13 NABC wins: five in the Reisinger Board-a-Match Teams (1968, 1970, 1981, 1985, and 1986); two in the Life Master Men's Pairs (1967 and 1984); four in the Grand National Teams (1982, 1983, 1985, and 1987); and two in the Vanderbilt Knockout Teams (1984 and 1987). He was a member of the victorious U.S. squad in the 1985 NEC Bermuda Bowl in São Paulo, Brazil, and second in the 1989 Bermuda Bowl in Perth, Australia.

Peter died in 1990 at the too young age of 54. He left the ACBL a substantial bequest for vugraphs at NABCs, to be known as the PenderGraph; these continued for several years but nothing was done with the fund after 1998. Thanks to the diligence of the Wolffs, and with the help of CEO Jay Baum, a motion was passed at the ACBL board meeting in Toronto that the vugraph room at future NABCs be named and advertised as the "Peter Pender Memorial Vugraph Theatre." A request was submitted to the Education Foundation (and approved) for the remaining monies from Peter's bequest to be used to purchase two large screen monitors that can be rolled into high traffic areas at NABCs for players to watch vugraph in a more relaxed atmosphere. Both of the rolling monitor cases will have brass plates attached that read "Provided by a bequest from Hall of Fame member Peter Pender." These were very well received in Toronto.

Present - Clement Jackson



Clem is an unassuming, "under the radar" bridge player who is D17's newest Grand Life Master. Clem, originally from Michigan, grew up in Santa Fe, New Mexico and now lives in Albuquerque. He started playing bridge in college in 1965 and, like most of us, became hooked. Clem retired several years ago after being a software developer and remains part owner of a software company. His national win was the Senior Knockout Teams at the 2003 New Orleans Fall NABC, with teammates Dennis Dawson, Bobby Wolff, Dan Morse, John Mohan, and John Sutherland.

Clem went over the required 10,000 points at the 2011 May Denver Regional playing Knockouts with teammates Venkatrao Koneru, Geoff Hampson, Susan Key, and Chris Compton (yes, my team and I helped him). He considers himself to have the good fortune to play with many good partners, and I believe his partners have the good fortune to play with him. Congratulations Clem!

Future - Burke Snowden



If Burke Snowden is an example of the future of bridge, then our future is bright indeed. Burke first started playing party bridge at six years old with his parents and grandmother. He followed his father to duplicate when he was nine years old and at the age of 11 became a certified club director. He directs the 199er game in Fort Collins and, when needed, substitutes directing the open game. Burke became a Life Master this May at the age of 13, and in July became a certified Tournament Assistant. He'll be working at the Cheyenne Paintbrush Sectional, September 16-19.

Burke has attended all four of the Youth NABCs, the first took place in July, 2008 in conjunction with the Fourth of July Sectional in Atlanta. At the second Youth NABC, during the 2009 Summer Washington, D.C. NABC, Burke met Ben Kristensen, from Duluth, Minnesota, as teammates on the National Youth Swiss Teams - afterward forming a partnership. They played together at the third Youth NABC at the 2010 New Orleans Summer NABC. Ben and Burke got it all together in Toronto as they won the regional Gold Rush Pairs tuning

Master Solvers Panel



By John Swanson
Lancaster, California

Thanks to this month's panel stalwarts: Jan Janitschke, Denver; Marshall Miles, San Bernardino; Ivar Stakgold, San Diego; Jill Meyers, Santa Monica; Edwin Kantar, Santa Monica; Chris Larsen, Costa Mesa; and David Weiss, Pasadena. They have all made significant contributions to the game of bridge. Their opinions deserve careful consideration - even when I rail against them.

Problem 1.

Neither side vul, IMPs
You are South holding:

♠42 ♥K5 ♦AKJ3 ♣Q8432

South	West	North	East
?	2♣	Pass	Pass

Janitschke: Pass. To assume partner is lying in wait for a double is a bit optimistic.

Miles: Pass. I have no good suit to bid, no heart support, no stopper. Partner's share of the missing high cards should be about 10 points, while I need about 13 plus a stopper. That is too much to hope for.

Stakgold: 3♣. It is easy to construct hands for North where 3NT is making and others that fail at any 3-level contract. Since a game is possible, I will make the only sensible bid despite the poor suit quality.

J.S.: That seems right on the mark to me. If partner has his expected high cards your side will be able to make a partscore. Partner could have a bit better than expected plus the honor locations are favorable, both improving the chances for 3NT. Also, the danger of getting overboard is mitigated because partner will know that you are expecting some values in his hand.

Meyers: 3♣. Do I love it? No, but my other choice is pass, and I love that less.

Kantar: 3♣. I'm not selling out with opening bid values.

Larsen: 3♣, a bit nervously. Pass is the only possible alternative.

J.S.: There always seems to an alternative:

Weiss: Double. No bid is comfortable, but I cannot afford to sell out as a routine pass by North yields an easy game (♠KJx ♥Axx ♦xxx ♣AJxx). The primary downside is that partner is likely to bid hearts, but that is not guaranteed to be fatal. If my king of hearts were instead the king of spades, I would go quietly.

J.S.: Double caters to a penalty pass, but this advantage is more than offset by partner's likely heart bid. He might well be bidding hearts on hands which belong in notrump. It is also a poor partnership bid; he may lose confidence in your takeout doubles.

Problem 2.

Vul vs. not, IMPs
You are South holding:

♠9 ♥A65 ♦KJ ♣AQ106532

Kantar: Pass. I have talked myself into passing, thinking how bizarre it is that I am bidding with the previous hand and passing with this one!

J.S.: Last hand you balanced with opening bid values. This time you already have entered a live auction vulnerable against not, so you have already shown a good hand. Is it worth the considerable risk to bid again? The strong consensus is no.

Meyers: Pass. All I have is one extra club for my vulnerable 3♣ bid. Partner didn't make a responsive double. I am out of here.

Janitschke: Pass. Yes, I have extras, but to do anything here is a big gamble.

Larsen: Pass. I would consider bidding at other vulnerabilities, but red versus white too many things can go wrong.

Miles: Pass. Game is remote if partner can neither raise nor double. My defensive chances look good with a club lead but I think I have more to lose than to gain by doubling.

Stakgold: Pass. A difficult decision. A double could work out if the opponents are trying to steal ... but maybe they simply have all the missing high cards!

Weiss: Double. I'm risking five IMPs (for -590 when partner has no high cards and nowhere to go) against the possibility of a large gain when partner is clever enough to hold something like: ♠xx ♥KQxxx ♦xxx ♣Kxx and we make 5♣. The 4♠ bidder, who is likely to be short in clubs, may have a long spade suit or a secondary diamond suit. These hand types suggest partner will have length in hearts. If he has honors there as well, we can make a game.

It is worth mentioning that a redouble by opener does not alter partner's responsibility. If partner passes, I will abide by his decision.

J.S.: A redouble may not change partner's responsibility, but it certainly increases your exposure. Your extra club length is good on offense if partner has a fit, but the doubleton king-jack of diamonds may be worthless on offense or defense. Bidding again looks too risky to me.

Problem 3.

J.S.: When this deal was played my partner responded 1NT. I informed him that he would not be able to find even one other expert who would bid 1NT - it was not an appropriate forum bidding problem. To my shock and dismay, the first two experts I presented the auction to both bid 1NT. There proved to be others. Because I admire the bidding judgment of each of them I must make a close examination of why my opinion is that a game forcing 2♣ is the correct call - and that it is not a close decision.

The advantage of a two-over-one system is that when you bid at the two-level it is a game force. Each partner can describe his hand, searching for the best game (or slam) without fear of being passed. The disadvantage comes when responder has a worthwhile suit but does not hold game-forcing values and can't bid his suit immediately. This can be costly. Sometime good fits may be lost when the suit is not bid by either partner; if the suit is bid a simple raise may be inadequate and a jump raise too risky.

On this hand the advantage of bidding 1NT is to be able to stop in 2NT when that is the exact limit despite having 24 or 25 high card points between the two hands, a very small target. For this possibility one gives up the opportunity to show the club suit and opening bid values, losing any intelligent way to investigate a club contract, even if partner should happen to bid the suit. There are other ways to lose by bidding 1NT. The opponents may bid (as they did) which could prove to be an effective preempt when all you have shown is less than opening bid values. Another possibility, which occurred on this hand, is that partner may choose to bid spades over notrump, not realizing that his spades are needed only as stoppers instead of a source of tricks. He will not realize that there are sufficient high cards and club winners in your hand for 3NT.

J.S.: What to do 1NT bidders have to say?

Janitschke: 1NT. No reason to drive to game with marginal values and a misfit.

Miles: 1NT. With my misfit, I don't want to force to game. I will probably bid 2NT next round ... unless partner bids hearts or clubs, or jumps in spades.

J.S.: You don't have a misfit - you have a spade void. You could have a fit in any of the other three suits, and after 1NT you have no adequate way to investigate the best game or slam.

Weiss: 1NT, forcing. This hand is not close to being as strong as the HCP suggest, and I will not force to game. If partner has an ordinary minimum such as ♠AKxxx ♥xxx ♦Kxx ♣Qx, our game prospects are poor. The better are partner's spades, the worse our prospects. And if partner happens to have been dealt extra values, the 2♣ overbid may nudge him overboard.

The difficult choice may come on the next round. If partner bids two of either rounded suit, I will bid game in that strain. If partner bids two of a pointed suit, I will hold to my evaluation and bid only 2NT. An upside of 1NT is that I know what to do if the intrepid opponents enter the auction.

J.S.: The statement that this hand is not close to being as strong as the high card

values is balderdash. You don't know what this hand is worth yet. If you bid 1NT partner won't know what it is worth either. And how could the auction go that you will be able to comfortably double the opponents when they enter the auction? If partner responds 2♣ you have lost all investigative auctions. A jump to 5♣ will not work so well if partner holds: ♠AKxxx ♥xx ♦Kxx ♣Qxx. Even if he holds the doubleton club of your example 3NT will make almost as often as 2NT. The only reason that there could be a difficult choice on the next round is because you have misbid on this round. After partner's rebid to 1NT you may feel more like you have a Ouija board at your right rather than a bidding box.

Stakgold: 2♣. Should I bid 1NT or 2♣? I see pluses and minuses to both. Either will get us to hearts if opener has four (or more) cards in the suit. The trouble with 1NT is that I may never get to bid my club suit even if 6♣ is the right contract. The trouble with 2♣ is conveying the wrong message as to the quality of the suit. Nevertheless, I bid 2♣ with the intention of rebidding 2NT over 2♣. If opener has ♠AKx in clubs and the ♦K or ♣KQx of clubs and ♦A, we will probably reach 6♣.

Meyers: 2♣. I have game values. I wasn't dealt any spades, but so what?

Larsen: 2♣. It will be too difficult to catch up if I start with a forcing notrump.

Kantar: 2♣. Finally, a no-brainer.

In an attempt to get a better idea of what might happen in this auction I generated 10,000 hands for North with the stipulation that it contain 12 or more high card points and five or more spades. (I also stipulated that the hand contain fewer than four hearts, making the assumption that the initial response would be unlikely to make a difference in that case.) Analysis of the first 100 hands disclosed exactly one which would make 2NT clearly the best contract. Meanwhile 41% of the North hands contained three or more clubs. It was also interesting to note that partner was frequently going to have a difficult decision on the next round after a 1NT response, while after 2♣ the auction would be comfortable for both players. (Anyone who wishes to look closely at the other 9,900 hands is welcome to the file.)

If your partnership routinely opens colorless 11 HCP hands with five spades, 1NT becomes more attractive. But those pairs will have a similar problem when holding 13 rather than 12 high card points. Don't get me wrong. 1NT could work. You might get to a making 2NT or be set one less in a poor 3NT. But the price you pay in exchange due to guesswork auctions will be too high.

J.S.: The panel, in toto, missed the point of the problem. I am disappointed (but not shocked or dismayed).

Meyers: Pass. I think it is close between passing 4♣ doubled and bidding 4NT; I am not forcing this to slam.

J.S.: A double of a 4♣ opening bid is most frequently used for takeout but with a balanced hand the double is usually passed. If your partnership uses double as penalties there is no good reason to bid with this hand.

Janitschke: Pass. My fourth wimpy call in a row. Partner should play me for a little something, though not necessarily this much.

Hand 2: You have jumped to 5♦ over East's third-hand opening of 1♠. Everyone passes, and the dummy you buy is disappointing, to say the least. West leads the ♠K. How do you play to make the contract? These hands are from Eddie Kantar's newest book, *Take All Your Chances at Bridge Vol. 2*, a great sequel to the first volume, which won the American Bridge Teachers Assn. award for Best Intermediate Book in 2010. I'm recommending both of these books to all players of all levels who want to improve their technique. Stakgold: Pass. Glad partner chose diamonds, but I am not worth another bid.

Larsen: Pass. It seems the bidding has developed as favorably as I could hope for, under the circumstances.

Miles: Pass. Partner may be gambling that I have this much strength, and suits usually don't break well in situations like this. But the decision is close now that partner has bid diamonds, my best suit.

Weiss: Pass. I don't understand why this is a problem now. On the previous round, I might have tried 5♥; but my choice of 4NT, suggesting a two-suiter, was quite reasonable. I would have removed 5♣ to 5♦, showing red suits. At IMPs, 5♦ and 5♥ are equally rewarding and my goal is merely to find a playable trump suit.

I got my wish when partner bid one of my suits. If I were to bid 5♥ now, that would suggest slam interest.

J.S.: That is the point missed. 5♥ now does not show slam interest. The 4NT call announced two places to play - any two of the three unbid suits. If your minor suits were reversed you would certainly correct 5♦ to 5♥.

If partner had bid 5♣ (instead of 5♦) and you remove to 5♥ it does show slam interest - otherwise you would have bid 5♥ immediately. (If you started with both minors, you would pass 5♦.) For completeness I will acknowledge that you could hold a 1-4-4-4 hand, but in that case with 4NT you have elected to treat it as a two-suiter.

Given that 5♥ is not forward going, why remove 5♦? As David points out, you will be pleased to make either 5♦ or 5♥. The answer is that partner has become an overwhelming favorite to hold at least four hearts. If he has exactly four hearts it may be crucial to play the 4-4 rather than 5-4 fit. Partner could easily hold: ♠xx ♥AQxx ♦AQxx ♣Axx or something similar. Then, you say, why not bid 5♥ immediately over 4NT? Because partner bypassed 5♣ deny-

ing a four-card club holding, thus making it likely that he holds at least four hearts.

Despite all this analysis 5♦ could be the winning contract, partner holding a strong 3-3-5-2 hand. But then, he could be 3-5-3-2 also. I believe that the percentage call is 5♥ rather than pass. But full credit if you even considered it.

Kantar: Content. Too much missing to bid on.

J.S.: I have often wished for a "Content" card in the bidding box. It would be used most often when the opponents are known to be in an inferior, even hopeless, contract.

J.S.: It's good to have a problem where I have no strong opinion. I can step aside and let the panel have their collective say.

Stakgold: 4♣. Hope to prevent the opponents from finding their best fit. If I am lucky they will land in hearts.

Meyers: 4♣, not getting fancy. It may go double all pass, but that may be best for the opponents. Partner could have a twist for a third seat opener (like five-five in the black suits) and make 4♣. Or we may be able to beat something at five-level. I do the vanilla thing.

Larsen: 4♣. Looks like a normal bid - might even make on a good day.

Kantar: 4♣. I may regret this if partner is too far out of the boat.

Miles: 4♠. I'm not going to try to outguess partner or the opponents.

J.S.: The dissenting opinions:

Weiss: 3♠. I don't see much point in taking what is virtually sure to be a minus score in 4♠, and it might get doubled on power. My red suit holdings make me unafraid of their game chances, and if they can stop on a dime in 4♣ more power to them. Partner may have taken liberties in third seat and could have a disappointing offensive hand.

Janitschke: I bid all of 3♠. Bidding 4♣

seems a bit much because I'm not sure they can make a game or even get to the right one (if one exists). Bidding four just gives them an easy double for down two or so. I don't like not having a spade honor and bidding 4♠.

J.S.: Those are strong arguments for 3♠. Your choice between 3♠ or 4♣ may depend on how much room partner needs for his third seat favorable vulnerability weak two. He needed lots of room at the table. 4♣ was doubled for a two trick set while East/West can take exactly ten tricks in clubs.

On this hand, the two main chances for 12 tricks are that diamonds split 3-3, or the ♠Q is with West. Although neither of these chances occur on this hand, there is an extra chance which works perfectly on this layout, if you understand the principle of a partial strip followed by a loser-on-loser play. Just draw trump, cash the two top diamonds, then lead the ♠Q and throw the lead to East with the ♠K, discarding your losing diamond! Now East has to lead a black card, so there is either a ruff-sluff or an endplay in spades. Only if East had 4 or 5 diamonds would it be necessary for the ♠Q to be with West. That makes the odds about 85% in favor of success.

Contract 5♦: This hand is much less happy. To make 11 tricks, you need the hearts to break 3-3, with the ♥K inside.

And since that requires two heart finesses, you had also better hope that West holds the ♦8, so that you have the two dummy entries necessary to take both heart finesses. Therefore, best play is to ruff the ♣K high, lead the ♦2 to hook against the ♦8, finesse in hearts, lead your other low trump to dummy's ♦10 winner to repeat the finesse; then ... when hearts behave, you claim your game.

The odds of all this coming true? Eddie says about 9%, and I believe him. But ... as Eddie also says, "playing for a 9% chance is still better than playing a 0% contract."

Bridge to a Better World

Heart pacemakers enhance and extend both the quality and quantity of life for many folks around the world. What happens to these marvelous devices, though, in the final analysis? Most of us are familiar with organ donation and the miraculous opportunity it may provide. Now there is a program in development to recycle pacemakers.

One might expect that as we age we are more likely to need a pacemaker. By extension, one might guess that there are more pacemakers per capita in the ACBL population of 165,000 (average age 69) than there are in a randomly selected group of 165,000 people. Different people choose different ways of caring for their earthly remains. Cemetery experts, however, assure us that pacemaker removal is a good idea prior to cremation (lest the crematorium explode!). Pacemakers removed prior to cremation or conventional burial are generally simply trashed. How sad - most have "life" (battery and/or mechanical) left in them that could be used by someone who could not otherwise afford one. An opportunity to save or improve someone else's life is lost. What a shame.

Project My Heart/Your Heart is a program of The University of Michigan Cardiovascular Center, headed by Dr. Kim Eagle (Clinical Director of the Cardiovascular Center) working with Dr. Thomas Crawford. It has a simple, but powerful, focus: recycle used pacemakers to individuals in developing nations and to others in need. Nations without strong health care programs cannot offer such wonderful life-extending devices to most of their residents. We can, as one individual to another. The University of Michigan team is establishing procedure for sterilizing used pacemakers so they can be safely transplanted from a cadaver to a living person. According to the Project My Heart/Your Heart website, each year 1-2 million individuals worldwide die due to lack of a pacemaker. Meanwhile, almost 90% of individuals with pacemakers would donate their device to others in need if given the chance.

If you or a loved one have a pacemaker, please reflect on whether you would like to donate it, eventually, to this program. In the beginning, donations are for research purposes only. Share your heart; help to develop a program to save lives. Consider getting in on the ground level of this synergistic merger of medical, technological, and environmental science. Become an "ACE"

of hearts!

Bidding: East's rebid of 2NT showed 18-19 high card points. With his good two-suited hand, West was interested in slam. East cooperated by first showing spade support and then cue-bidding the ♦A. South doubled 4♦ hoping to get a diamond lead.

Play: The only thing North remembered from the bidding was his partner's double so he cooperated by leading a diamond against the six level contract. Declarer won the diamond lead, lost a trump trick, and quickly claimed 12 tricks. If North had only listened to the bidding, he would have realized that declarer bid clubs twice to show at least five, dummy jumped to 2NT

Bidding Basics 5, Opener's Rebids

By Kitty & Steve Cooper

When deciding what to do over your partner's response to your opening bid of one of a suit remember your bidding objectives: finding out if there is an eight card or longer major suit fit and if the partnership has the 26 points (or 14 losers) needed for game.

Let's cover the easiest case first. Suppose you open one of a major and partner gives you a limit raise. Since partner has shown 11-12 support points, conventional wisdom is to bid game with a good 14 or more points and consider slam with about 20 points. Forget that. This is the time when you want to use losing trick count, covered in the previous article in this series, to evaluate. Partner has shown an eight loser hand so bid game with six losers. If you have four losers you should think about slam.

Onward to the tougher cases. What does partner's response to your opening bid tell you about your possible major suit fits and your partnership points? If you know that the partnership cannot have 26 points or 14 losers, you want to pass or make a sign-off bid. If you have found an eight card major fit, that's the suit you want to have for a trump suit so raise it. Here is a chart showing the three categories to divide your opening hand into:

Point Range	Category	Opposite a Minimum Raise	When Raising Responder
13-15 (6 or 7 losers)	Minimum	pass	two level
16-18 (or 5 losers)	Medium	invite	three level
19-21 (or 4 losers)	Maximum	game	game

Rebid Question List

1. *Is there an eight card major suit fit?* The priorities, in order, are: raise partner's major, bid a new major at the one level, or "raise" yourself. So with

four card support for partner's suit or a six card or longer suit of your own:

- Raise to two with a minimum
 - Raise to three with a medium strength hand (or a five loser hand)
 - Raise to game with a maximum. When raising a minor this can mean bidding 3NT.
2. *Is your hand balanced?* If so then:
- With a minimum rebid the cheapest number of NT or pass partner's NT response
 - You will not have a medium hand unless you have a five card major, since you would have opened 1NT. If you did open one of a major with 15 or 16 HCP, then you have to rebid two of a three card minor (Note that if you have a four card minor, you are not balanced).
 - With a maximum, jump in NT or raise partner's NT bid one level. This can include 17 HCP with a five card major or possibly a six card minor not suitable for a three level jump rebid.
3. *Your hand must be unbalanced*, therefore bid a new suit if possible
- A minimum hand can only bid a new suit when it can be bid below two of the suit that was opened. Therefore sometimes a minimum hand has to rebid a five card suit; this will usually be a minor.
 - A medium hand makes a natural rebid of a second suit. Note that a reverse, (bidding a new suit higher than two of the suit opened, for example 1♣-1♠-2♥) promises at least medium strength values.
 - A maximum hand needs to force to game. Therefore a maximum must either jump in a new suit (a strong jump shift) or reverse and then follow with another strong bid or bid of game.

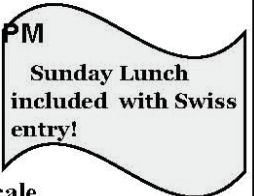

Roman Keycard Blackwood (RKC), Part 10

We present here the tenth in an occasional series on Roman Keycard Blackwood (RKC).

Sometimes those nasty people sitting to your left and right decide to enter the auction after you bid RKC - usually they will have bid a suit before bidding above 4NT, but not always. For example, if the auction begins 1♠-Pass-4♣ (splinter)-Dbl, and you bid 4NT, RKC, LHO may decide to enter with a bid of 5♣. Or the auction may begin 1♠-Pass-4NT (RKC) and LHO throws in a double (which we play as asking for the lead of the lowest suit you couldn't have otherwise asked for, here clubs). It's good to know what you're doing here.

There are three relevant acronyms: DOPI, DEPO, and ROPI. DOPI stands for "double zero pass one." Until very recently we would have told you that the meaning was obvious: if you double you are making the bid that would have shown either three or zero keycards had the enemy passed (the second step if you play 1430, the first step if you play 3014); if you pass you are making the bid that would have shown one or four keycards. But in Toronto one of us played with a good partner who, even though we were playing 1430, thought that double showed the first step. There's no theoretical advantage to playing either way, but it's probably worth the three seconds it will take you to clear that up before you start playing.

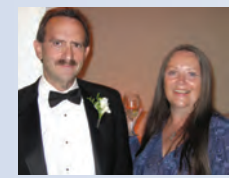
ROPI stands for "redouble zero pass one." Again, pre-Toronto we would have thought that the meaning was obvious, but apparently not - as above, at least one Canadian player thinks that double shows one or four, even when playing 1430. Obviously ROPI is only relevant when the enemy doubles 4NT. DEPO stands for "double even pass odd."

Fortunately there's no ambiguity about what an even number of keycards is and what an odd number is (except that zero is an even number for these purposes; if you're a mathematician and are aghast at what we just said, please understand that we're speaking bridge, not math).

So if the enemy bids over your bid of RKC the only remaining question, if you play both DOPI and DEPO, is which one applies. You'll be happy to hear that the answer is simple: if you can still bid 5♥ to show two keycards without the queen of trump you play DOPI; if not you play DEPO. An example should make this clear: If partner opens 1♠ and you hold ♠J10xx ♥KQ ♦KQJ10 ♣AKQ you might well bid 4NT - if partner has three keycards with the queen you'll bid a slam, otherwise you should be safe in 5♣ (surely he has to have at least two keycards). But what if the enemy throws in a 5♥ bid - obviously partner can no longer bid 5♥ to show two without, but if you didn't play DEPO and switch here, partner could bid 5NT to show two keycards with the queen (double being the step that shows three or zero and pass being the step that shows one or four), leaving you forced to bid 6♣ anyway, even knowing that you're off two keycards. (As an aside, it seems to be fashionable these days to bid slam missing a keycard and the queen; maybe that's not so bad when you know we have at least nine trumps - the odds of bringing in a nine card suit to the ace-king missing the queen for no losers is 52% - but it's still considered proper to have at least four of the five keycards!)

Consult the Coopers

Ed Schwartz of Phoenix, Arizona asks "How frequently do experts play weak jump shifts not in competition rather than strong jump shifts? What do you think is best?"

Coopers: The top pairs do not use weak jump shifts unless they play a strong club system, and not often even then. Many pairs who do not play Bergen raises use invitational-to-game jump shifts to the three level (as we do). Some modernists play that the jumps to two of a major over one of a minor show weak (2♥) or invitational (2♠) hands with five spades and four hearts, since it is often difficult to find the heart fit with those hands in standard bidding.

For those of our readers unfamiliar with weak jump shifts over opening bids, they show hands that are barely worth a response, usually 3-6 points mostly in the six card or longer suit with no outside ace or king. In some partnerships AQxxxx is too good a suit. Opener usually passes the bid unless he has a fit. This is more restrictive than a weak jump shift in competition which can be a bit better, more like 6-8 points, particularly vulnerable.

We do not recommend using weak jump shifts in a standard-style system. The strong jump shift to the two level handles an important hand where slam is possible: about 17+ points and either a single-suited hand, a balanced hand with a good 5+ card suit, or a hand with a fit and its own semi-solid suit. Many experts prefer the Soloway responses to this bid, where opener almost always bids the next step as an artificial ask to learn which hand partner has, but that is a topic for another article.

A little research to support our assertion seemed in order, so we went to www.ecatsbridge.com/documents/docdefault.asp?page=ConventionCards and to www.BridgeWinners.com to look at convention cards. Many world champion pairs, such as the current Italian team, Hamman, and others play totally artificial meanings for responder's jump shifts, including various raises and the major suit hand mentioned above. The only weak jump shifts we found were 2♠ over 1♥ by Meckwell and three of a minor over a major by Kit Woolsey-Fred Stewart. Other world champion pairs with natural systems who play strong jump shifts are Bobby Levin-Steve Weinstein and Peter Boyd-Steve Robinson and to some extent Chip Martel-Lew Stansby (not over one of a minor).

We even found a world class pair that play strong jump shifts to all levels, Adam Wildavsky-Doug Doub. The great Italian (Monaco now) pair Fulvio Fantoni-Claudio Nunes (aka the Fantunes) play most of responder's jump shifts as strong. Finally the famed Norwegian pair, Geir Helgemo-Tor Helness (also now Monaco) play as we recommend above.
