

Real DVD

- Does not disable CSS encryption and includes CSS encryption on copied version along with a second layer of encryption.
- Allows copying of single DVD to five hard disks, but requires license for each each copy.
- Once copy is made, the copy is tethered to that hard disk.

Indirect © infringement?

- Grokster (intentional indirect infringement)
 - Sought customers looking to infringe (Napster)
 - Did not attempt to use technology to prevent infringement
 - Business model based on infringement

 Sony (possibility of substantial noninfringing uses negates indirect infringement)

MPAA's Suit

- DMCA (circumvented a technological measure)
- Breached CSS License
 - "CSS Specifications"
 - Only watch movie when DVD is physically present
 - http://www.dvdcca.org/css/

- Prior suit with Kaleidoscope (appeal pending)
 - No breach of CSS License
